We can't wait to welcome you to Prince's to enjoy some of the finest links golf on the Kent Coast.

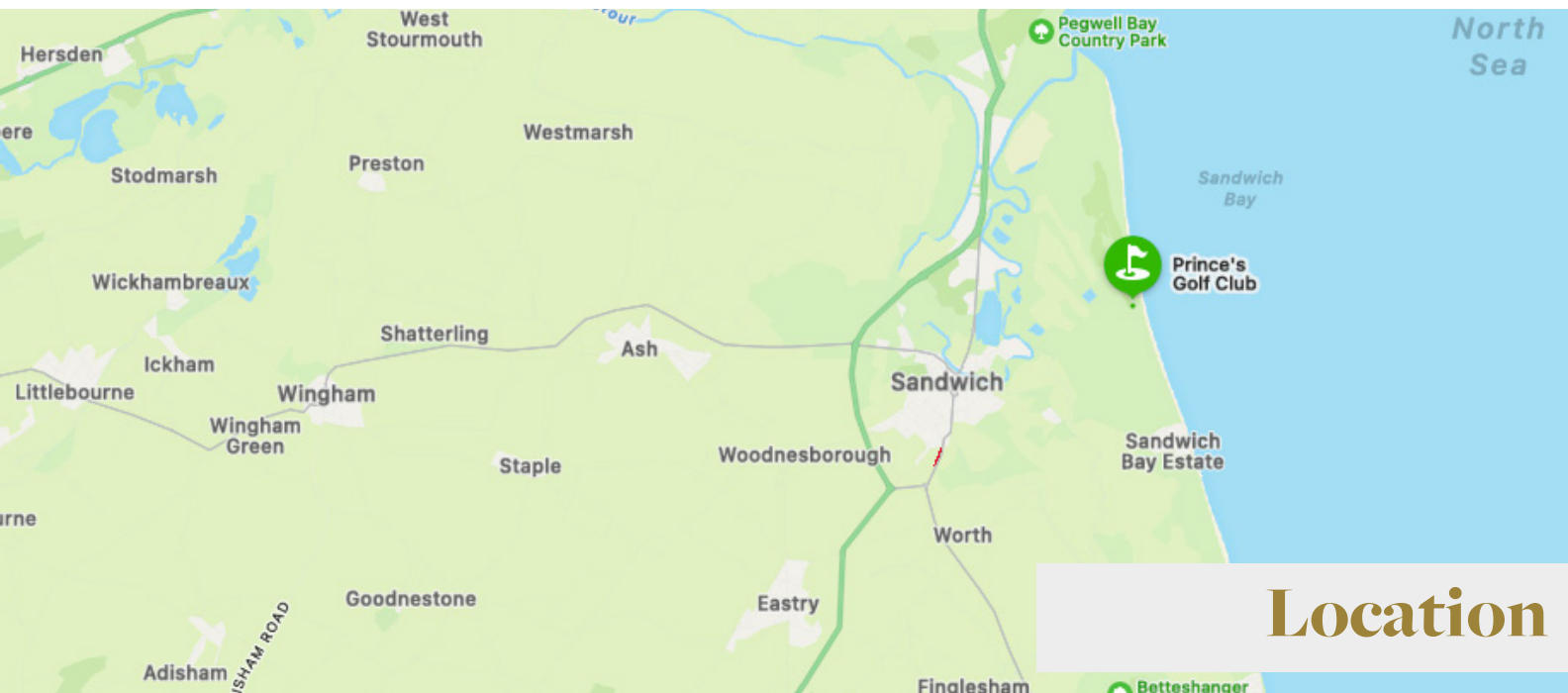
We want to make sure you have the best experience possible when joining us for a meeting or conference, so we have compiled some key information for you ahead of your visit.



Arrival

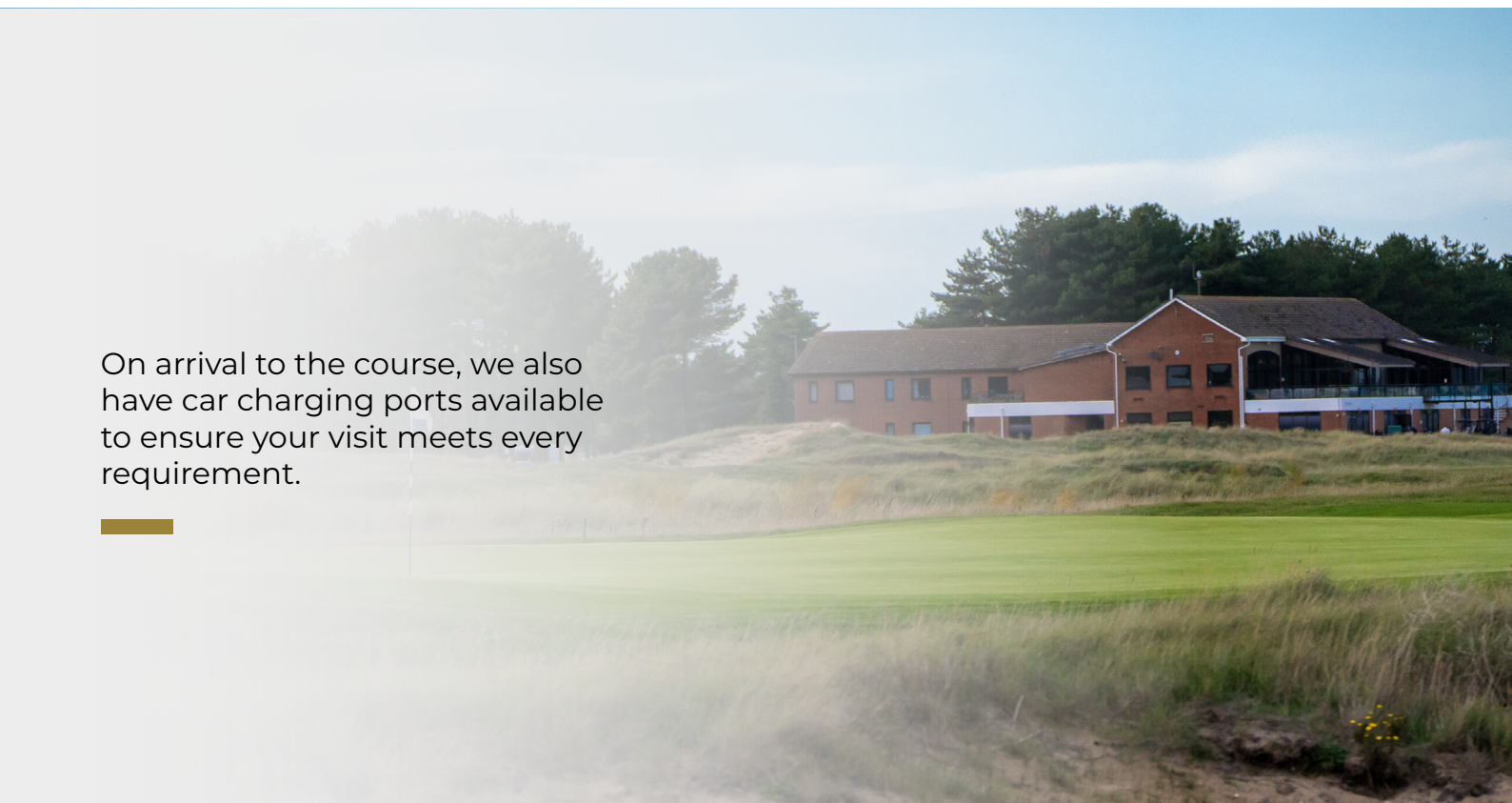


The Clubhouse

This boardroom setup can accommodate 16 guests, with an alternative theatre set up available for 20 guests.

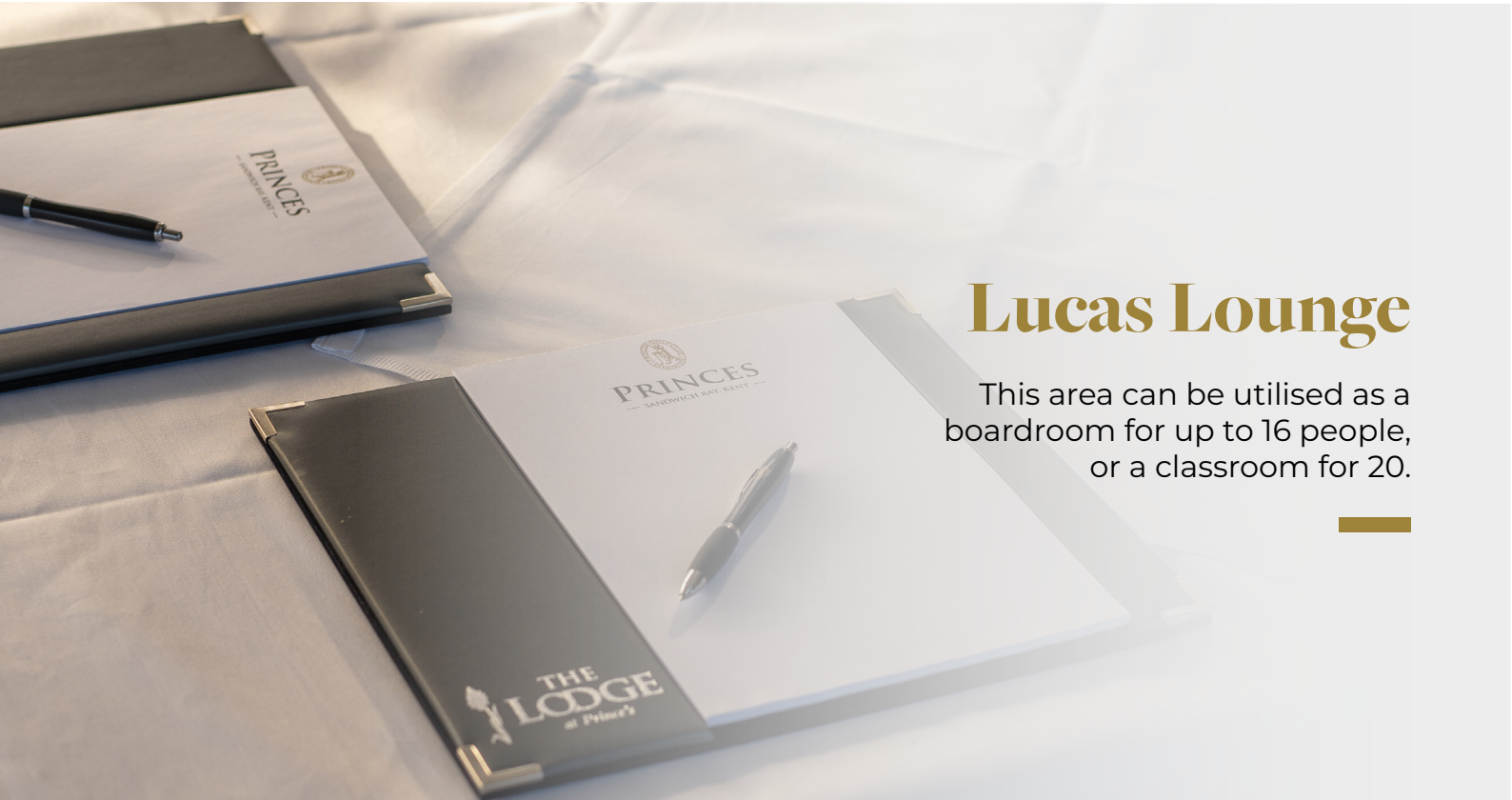


On arrival to the course, we also have car charging ports available to ensure your visit meets every requirement.



The Lodge

Our Lodge is conveniently located just a short drive from the Clubhouse, and is a great spot to welcome guests for a meeting. We have the Lucas Lounge that can be made up for your requirements, depending on the number of guests attending.



Lucas Lounge

This area can be utilised as a boardroom for up to 16 people, or a classroom for 20.

Terms and Conditions

In addition to our published terms and conditions, reservation agreements and booking conditions are as follows.

- An initial non-refundable deposit of £25.00 per person will secure the reservation.
- Any booking is provisional until the venue receives a signed copy of these terms from the Client or written confirmation of booking from the Client, receipt of which will be deemed to be the Clients acceptance of these terms.
- Settlement of any outstanding invoices must be made prior to departure, unless agreed in advance.
- All prices inclusive of VAT are at the current rate. All prices quoted may only vary when changes affect VAT or reasons outside the venues control, of which the Client will be notified immediately.
- We request a minimum of 10 full paying guests. Final numbers are requested minimum 1 week prior to the event. Full payment of each person not attending will be required should the numbers drop below 10.
- In the event that the Hirer cancels a confirmed booking, the following charges will be applied:

Terms and Conditions

- Less than two months' notice 25% of room hire, Less than 28 days' notice 50% of room hire, Less than 14 days' notice 75% of room hire, Less than five working days' notice 100% of room hire and catering charges.
- Prince's Golf Club reserves the right to refuse any function likely to cause unnecessary disturbance to the other guests.
- The Hirer is responsible for the Health and Safety of their staff and delegates throughout the duration of the hire period, and will be expected to comply with all relevant legislation.
